| <p>1. <u>Constitution</u></p> <p>1.1 The Committee is established pursuant to a resolution passed by the Board at its meeting held on 23 July 2013.</p> | <p>組成</p> <p>本委員會是按本公司董事會於2013年7月23日會議通過成立的。</p> |
| <p>2. <u>Membership</u></p> <p>2.1 Members of the Committee shall be appointed by the Board from amongst the non-executive directors only of the Company and shall consist of not less than three members, a majority of whom should be independent non-executive directors. At least one member is an independent non-executive director with appropriate professional qualifications or accounting or related financial management expertise as required in rule 3.10(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”).</p> <p>2.2 The chairman of the Committee shall be appointed by the Board and shall be an independent non-executive director.</p> <p>2.3 The company secretary of the Company shall be the secretary of the Committee.</p> | <p>成員</p> <p>委員會由董事會從其非執行董事中委任組成，委員會人數最少三名，大部分委員應為獨立非執行董事，其中至少一名須按照香港聯合交易所有限公司證券上市規則(“上市規則”)第3.10(2)條具備適當專業資格或會計或相關財務管理知識。</p> <p>委員會主席由董事會委任及必須是獨立非執行董事。</p> <p>本公司的公司秘書為委員會的秘書。</p> |

2.4 The appointment of the members or secretary of the Committee may be revoked, or additional members may be appointed to the Committee by separate resolutions passed by the Board and by the Committee.

3. **Proceedings of the Committee**

3.1 ***Notice:***

- (a) Unless otherwise agreed by all the Committee members (either orally or in writing), a meeting shall be called by giving at least seven days' notice.
- (b) A Committee member may and, on the request of a Committee member, the secretary to the Committee shall, at any time summon a Committee meeting. Notice shall be given to each Committee member in person orally or in writing or by telephone or by email or by facsimile transmission at the telephone or facsimile or address or email address from time to time notified to the secretary by such Committee member or in such other manner as the Committee members may from time to time determine.
- (c) Any notice given orally shall be confirmed in writing as soon as practicable and before the meeting.

會議程序

會議通知：

- (a) 除非委員會全體成員(口頭或書面)同意，委員會的會議通知期，不應少於七天。
- (b) 任何委員會成員或委員會秘書（應委員會成員的請求時）可於任何時候召集委員會會議。召開會議通告必須親身以口頭或以書面形式、或以電話、電子郵件、傳真或其他委員會成員不時議定的方式發出予各委員會成員不時通知秘書的電話或傳真號碼或電郵地址或郵寄地址。
- (c) 以口頭通知方式召開的會議，應儘快(及在會議召開前)以書面方式確實。

(d) Notice of meeting shall state the purpose, time and place of the meeting and shall be accompanied by an agenda together with other documents which may be required to be considered by the members of the Committee for the purposes of the meeting. In respect of regular meetings of the Committee to be held as mentioned in clause 3.4 below, and so far as practicable for all other meetings of the Committee, the agenda and accompanying papers shall be sent in full to all the members of the Committee in a timely manner and at least 3 days before the intended date of the meeting of the Committee (or such other period as all the Committee members may agree).

3.2 **Quorum:** The quorum of the Committee meeting shall be two members of the Committee.

3.3 **Attendance:** The finance director, the head of internal audit (or any officer(s) assuming the relevant functions but having a different designation) and a representative of the external auditors shall normally attend meetings. Other Board members shall also have the right of attendance. However, at least twice a year the Committee shall meet with the external auditors without executive Board members present.

3.4 **Frequency:** Meetings shall be held at least twice annually or more frequently if circumstances require and with unanimous written consent to consider the budget, revised budget and, if published for publication, quarterly report prepared by the Board. The external auditors may request the chairman of the Committee to convene a meeting, if they consider that one is necessary.

4. **Written resolutions**

法定人數: 法定人數為兩位成員。

出席: 主管財務的董事，公司內部核數的主管(或任何主管承擔類似工作，但被指定為不同職稱)及一位外聘核數師的代表通常應出席會議。其他董事會的成員亦有權出席會議。無論如何，委員會應至少每年兩次在沒有董事會的執行董事出席的情況下，會見外聘核數師。

開會次數: 每年最少開會兩次或(若有所需及有一致書面同意時)多於兩次，討論董事會提呈的預算、修訂預算及(若發行公布)季度報告草稿。如外聘核數師認為需要，可要求委員會主席召開會議。

書面決議

- 4.1 Written resolutions may be passed by all Committee members in writing. 委員會成員可以以書面贊成方式通過任何決議，惟有關書面決議必須由所有委員會成員簽字。
5. **Alternate Committee members** 委任代表
- A Committee member may not appoint any alternate. 委員會成員不能委任代表。
6. **Authority of the Audit Committee** 審核委員會的權力
- 6.1 The Committee may exercise the following powers: 委員會可以行使以下權力：
- (a) to seek any information it requires from any employee of the Company and its subsidiaries (together, the “Group”) and any professional advisers (including auditors), to require any of them to prepare and submit reports and to attend Committee meetings and to supply information and address the questions raised by the Committee; (a) 要求本公司及其任何附屬公司(統稱為“本集團”)的任何雇員及專業顧問(包括核數師)準備及提交報告及出席委員會會議提供所需資料及解答委員會提出之問題；
- (b) to monitor whether the Group’s management has, in the performance of their duties, infringed any policies set by the Board or any applicable law, regulation and code (including the Listing Rules and other rules and regulations from time to time determined by the Board or a committee thereof); (b) 監控本集團管理人員在履行職務時有否違反董事會訂下的政策或適用的法律、守則(包括上市規則及董事會或其委員會訂立的規則)；
- (c) to investigate any activity within these terms of reference and all suspected fraudulent acts involving the Group and request the management to make investigation and submit reports; (c) 調查本職權範圍中的任何活動及所有涉及集團的懷疑欺詐事件及要求管理層就此等事件作出調查及提呈報告；
- (d) to review the Group’s internal control procedures and system; (d) 評審本集團內部監管措施及系統；
- (e) to review the performance of the Group’s employees in the accounting and internal audit department; (e) 評審本集團的會計及內部核數部門雇員的表現；

- s) to develop and review the Company's policies and practices on corporate governance and make recommendations to the Board;

- u) to review and monitor the Company's policies and practices on compliance with legal and regulatory requirements;
- u) 檢討及監察本公司在遵守法律及監管規定方面的政策及常規；
- v) to develop, review and monitor the code of conduct and compliance manual (if any) applicable to employees and directors; and
- v) 制定、檢討及監察雇員及董事的操守準則及合規手冊（如有）；及
- w) to review the Company's compliance with the code and disclosure in the corporate governance report.
- w) 檢討本公司遵守守則的情況及在企業管治報告內的披露。

8. Reporting procedures

會議紀錄及書面決議的傳閱

- 8.1 Full minutes of the meetings of the Committee and all written resolutions of the Committee should be kept by the secretary of the Committee.
- 委員會的完整會議紀錄及書面決議應由委員會秘書保存。
- 8.2 The secretary of the Committee shall circulate the draft and final versions of minutes of the meetings or, as the case may be, written resolutions of the Committee to all Committee members for their comment and records within a reasonable time after the meeting or the passing of the written resolutions.
- 委員會秘書應於委員會會議結束後或書面決議簽署前的合理時段內，把會議紀錄或書面決議（視乎情況而定）的初稿及最後定稿發送委員會全體成員（初稿供成員表達意見，最後定稿作其紀錄之用）。

8.3 The secretary of the Committee shall keep record of all meetings of the Committee held during each financial year of the Company and records of individual attendance of members of the Committee, on a named basis, at meetings held during that financial year.

委員會秘書應將各財政年度委員會舉行的會議會議紀錄及個別成員出席紀錄備存於本公司。

9. Continuing application of the articles of association of the Company

本公司組織章程的持續適用

9.1 The articles of association of the Company regulating the meetings and proceedings of the directors so far as the same are applicable and are not replaced by the provisions in these terms of reference shall apply to the meetings and proceedings of the Committee.

就前文未有作出規範，但本公司章程細則作出了規範的董事會會議程序的規定，適用於委員會的會議程序。

10. Powers of the Board

董事會權力

10.1 The Board may, subject to compliance with the articles of association of the Company and the Listing Rules (including the Corporate Governance Code and Corporate Governance Report set out in Appendix 14 to the Listing Rules or if adopted by the Company, the Company's own code of corporate governance practices), amend, supplement and revoke these terms of reference and any resolution passed by the Committee provided that no amendments to and revocation of these terms of reference and the resolutions passed by the Committee shall invalidate any prior act and resolution of the Committee which would have been valid if such terms of reference or resolution had not been amended or revoked.

本職權範圍所有規則及委員會通過的決議，可以由董事會在不違反公司章程及上市規則的前提下(包括上市規則之附錄十四《企業管治守則》及《企業管治報告》或公司自行制定的企業管治常規守則(如被採用))，隨時修訂、補充及廢除，惟有關修訂、補充及廢除，並不影響任何在有關行動作出前，委員會已經通過的決議或已採取的行動的有效性。
