SUMMARY

- The Offer Price has been determined at HK\$1.11 per Offer Share (exclusive of brokerage of 1.0%, SFC transaction levy of 0.003% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$1.11 per Offer Share, the net proceeds from the Share Offer to be received by the Company, after deduction of the underwriting fees and estimated expenses in connection with the Share Offer and assuming the Over-allotment Option is not exercised, are estimated to be approximately HK\$83.1 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future plans and use of proceeds” in the Prospectus.
- The Public Offer Shares initially offered under the Public Offer have been very significantly over-subscribed. A total of 5,450 valid applications have been received pursuant to the Public Offer on WHITE and YELLOW Application Forms and through giving electronic application instructions to HKSCC via CCASS or to the HK eIPO White Form Service Provider under the HK eIPO White Form services and for a total of 1,773,708,000 Public Offer Shares, representing approximately 177 times of the total number of 10,000,000 Public Offer Shares initially available for subscription under the Public Offer. NET PROCEEDS FROM THE SHARE OFFER

Based on the Offer Price of HK\$1.11 per Offer Share, the net proceeds from the Share Offer to be received by the Company, after deduction of the underwriting fees and estimated expenses in connection with the Share Offer and assuming the Over-allotment Option is not exercised, are estimated to be approximately HK\$83.1 million. The Company intends to apply such net proceeds as follows:

- approximately 65.0% of the net proceeds or HK\$54.0 million will be used as development costs of the Group's second data centre building in Hong Kong, including the payment of land premium for lease modification and construction costs. The Company expects that the aforesaid development will be divided into three phases, and approximately 47%, 9% and 9% of the net proceeds will be used for phase one, phase two and phase three of the aforesaid development, respectively. Apart from the net proceeds, the aforesaid development will also be funded by banking facilities and cash flows from the Group's operations. - approximately 24.5% of the net proceeds or HK\$20.4 million will be used as initial outlay for the Group's new construction projects such as making payments to suppliers and sub-contractors in advance of receiving payments from customers;

At the close of the application lists at 12:00 noon on Friday, 2 August 2013, a total of 5,450 valid applications (including applications on WHITE and YELLOW Application Forms and through giving electronic application instructions to HKSCC via CCASS or to the HK eIPO White Form Service Provider under the HK eIPO White Form services) for a total of 1,773,708,000 Public Offer Shares were received pursuant to the Public Offer, representing approximately 177 times of the total number of 10,000,000 Public Offer Shares initially available for subscription under the Public Offer.

The Directors confirm that no Offer Shares have been allocated to applicants who are existing Shareholders, Directors, chief executive, or connected persons of the Company or their respective associates (both within the meanings of the Listing Rules), whether in their own names or through nominees. None of the Sole Sponsor or the Sole Lead Manager or any of the other Underwriters or their affiliated companies and connected clients (as set out in Appendix 6 to the Listing Rules) has taken up any Offer Shares for its own benefit under the Share Offer. The Directors confirm that the Placing has been conducted in compliance with the placing guidelines for equity securities as set out in Appendix 6 to the Listing Rules. None of the placees under the Placing will become a substantial Shareholder (within the meaning of the Listing Rules) of the Company after the Placing and, assuming the Over-allotment Option is not exercised, the Company’s public float percentage will be at least 25% which meets the minimum percentage prescribed by Rule 8.08 of the Listing Rules.
