Reference is made to the circular of the Company dated 24 June 2020 (the "Circular") in relation to, among others, the proposed Bonus Issue. Unless otherwise state, capitalised terms used herein shall have the same meaning as defined in the Circular.

The proposed Bonus Issue on the basis of one (1) Bonus Share for every one (1) existing Share held on the Record Date was approved by the Shareholders in AGM held on 27 July 2020. On the basis of 709,771,173 existing Shares in issue as at the date of the Circular and assuming that there is no change to the number of issued Shares prior to the Record Date, 709,771,173 Bonus Shares will be issued representing 100% of the existing issued share capital. After completion of the Bonus Issue, there will be a total of 1,419,542,346 Shares in issue as enlarged by the Bonus Issue. For details, please refer to the Circular.
